SCHEDULE 1

- 1 Section 1 of the Fines Enforcement Regulation, B.C. Reg. 187/96, is amended by adding the following definition:
 - "Yuulu?il?ath" means the Ucluelet First Nation as defined in section 29.1.1 of the Maa-nulth First Nations Final Agreement.
- 2 Section 2 is amended

 - (a) Tsawwassen First Nation;
 - (b) Huu-ay-aht First Nations;
 - (c) Ka:'yu:'k't'h' /Che:k'tles7et'h' First Nations;
 - (d) Toquaht Nation;
 - (e) Uchucklesaht Tribe;
 - (f) Yuulu?il?ath;
 - (g) Tla'amin Nation.
- 3 Section 3 and the certificate attached to that section are repealed and the following substituted:
