



On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that, effective August 7, 2024,

- (a) sections 9 and 10 of the *Miscellaneous Statutes Amendment Act, 2024*, S.B.C. 2024, c. 10, are brought into force,
- (b) section 4.28 (2) (f) of the *Motor Vehicle Act Regulations*, B.C. Reg. 26/58, is amended by striking out “, while transporting a person in the lawful custody of a sheriff”,
- (c) section 5 (c) of the *Use of Electronic Devices While Driving Regulation*, B.C. Reg. 308/2009, is amended by striking out “, while transporting a person in the lawful custody of a sheriff”, and
- (d) the *Violation Ticket Administration and Fines Regulation*, B.C. Reg. 89/97, is amended as set out in the attached Appendix.
